



SCHOOL PHOTOGRAPHIC AND FILM CONSENT FORM

We often take photographs or video film for publicity purposes. These images may appear in our printed publications, for example our prospectus, or on our School website and we may send them to the media. We need your permission to do this.

We often display pupil's work around the school but for data protection purposes we need your permission to display work with your child's name attached. We would also like to display photos of children at times in the school (eg School Council) with their first names.

We also monitor the external areas of the school with CCTV cameras at all times for security purposes (please see the school website for full explanation of our CCTV policy).

CONDITIONS OF USE

1. This form is valid for the duration of your child's enrolment at St. George's School from the date of signing. However if your circumstances change and you wish to opt out or opt back in please contact the school for a new form.
2. Please be aware when signing this form that images of your child on the school website and school prospectus may be kept on there after your child has left the school.
3. We will not re-use any images after this time.
4. We will not include details or full names (which means first name and surname) of any child or adult in an image on video, on our website, or in printed publications, without good reason. For example, we may include the full name of a competition prize-winner if we have their consent. However, we will not include the full name of a model used in promotional literature.
5. We will not include personal e-mail or postal addresses, or telephone or fax numbers on video or on our website or in printed publications.
6. If we use images of individual pupils, we will not use the name of that child in the accompanying text or photo caption without good reason. And if a pupil is named in the text, we will not use a photograph of that child to accompany the article without good reason. For example, we may include a picture and full name of a competition prize-winner if we have their consent. However, we will not include a picture and full name of a model used in promotional literature.
7. We may use group or class images with very general labels, such as "a science lesson" or "making Christmas decorations".
8. We will only use images of pupils who are suitably dressed, to reduce the risk of such images being used inappropriately.
9. We cannot film or take photographs of any child that is at risk or under a supervision order.
